Mitch Winkler will be returning for his fourteenth season as the tennis professional at the Tavistock Hills Swim Club. Mitch comes with an extensive background as a player, teacher, and coach. Mitch was a former *Courier Post* All-South Jersey Player of the Year, and a former Number 1 ranked junior and twice half of the Number 1 ranked Men's Doubles Team in New Jersey.

In 2021, Mitch was inducted into the inaugural class of the South Jersey Tennis Hall of Fame. He has been the tennis professional for the Haddonfield Tennis Association for over 15 Years. Mitch also coached the Girls Tennis Team at Paul VI High School for 10 years and Bishop Eustace Prep School for 6 years. In 2002, Mitch led Paul VI to its first and only South Jersey Parochial A Championship and was selected as the *Philadelphia Inquirer* South Jersey High School Girls Tennis Coach of the Year. In 2015 Mitch coached the Bishop Eustace Girls Team to the South Jersey Non-Public A Sectional Championships, becoming the only girls coach in South Jersey history to win a sectional championship at 2 different schools.
